CALL FOR PROPOSALS

Legal Consultant or Law Firm to Draft Regulations under the FSM Biosecurity Act (PL No. 19-174)

The Federated States of Micronesia (FSM) Department of Resources & Development, through the GEF6 Invasive Alien Species (IAS) Project, is seeking a qualified legal consultant or law firm to draft the necessary rules and regulations to operationalize the **FSM Biosecurity Act (Public Law No. 19-174)**.

Objective:

To develop comprehensive, enforceable regulations that will give effect to the FSM Biosecurity Act, enabling its practical implementation and alignment with both national and state-level biosecurity frameworks.

Scope of Work:

- Review and analyze PL 19-174 and any related legislation or policies;
- Conduct consultations with relevant national and state stakeholders;
- Draft rules and regulations to ensure the effective implementation of the Biosecurity Act;
- Revise drafts based on stakeholder feedback and legal review;
- Support the legal validation and adoption process as needed.

Eligibility Criteria:

- Accredited law firm or licensed legal practitioner with a degree in law (JD, LLB, or equivalent);
- Demonstrated experience in legal drafting, ideally in administrative, environmental, or biosecurity law;
- Familiarity with FSM's legal system or experience in Pacific island legal contexts is preferred;
- Proven ability to consult with multiple stakeholders and deliver quality outputs under tight timelines.
